Further, I hereby give my consent to Fifth Avenue Pediatrics to administer the COVID-19 vaccine.
- Pfizer BioNTech COVID-19 vaccine product has been fully approved and licensed by the U.S. Food and Drug Administration (FDA). This FDA approval and license is for use in individuals 16 years of age and older only. The Moderna COVID-19 vaccine product has also been fully approved and licensed by FDA. This FDA approval and license is for use in individuals 18 years of age and older only.
- I understand that this product (other than Pfizer and Moderna for usage in ages mentioned above only) has not been approved or licensed by FDA, but has been authorized for emergency use by FDA, under an Emergency Use Authorization (EUA) to prevent Coronavirus Disease 2019 (COVID-19) for use in individuals either 6 months-15 years of age (Pfizer) or 6 months-17 years (Moderna) or 18 years of age and older (Johnson and Johnson); and the emergency use of this product is only authorized for the duration of the declaration that circumstances exist justifying the authorization of emergency use of the medical product under Section 564(b)(1) of the Food, Drug, and Cosmetic Act unless the declaration is terminated or authorization revoked sooner.
- I understand that it is not possible to predict all possible side effects or complications associated with receiving vaccine(s). I understand the risks and benefits associated with the above vaccine and have received, read and/or had explained to me the Emergency Use Authorization Fact Sheet on the COVID-19 vaccine I have elected to receive. I also acknowledge that I have had a chance to ask questions and that such questions were answered to my satisfaction.
- I acknowledge that I have been advised to remain near the vaccination location for approximately 15 minutes (or more in specific cases) after administration for observation. If I experience a severe reaction, I will call 9-1-1 or go to the nearest hospital.
- On behalf of myself, my heirs and personal representatives, I hereby release and hold harmless the Fifth Avenue Pediatrics, State of Florida, the Florida Department of Health (DOH), the Florida Division of Emergency Management (FDEM) and their staff, agents, successors, divisions, affiliates, subsidiaries, officers, directors, contractors and employees from any and all liabilities or claims whether known or unknown arising out of, in connection with, or in any way related to the administration of the vaccine listed above.
- I acknowledge that: (a) I understand the purposes/benefits of Florida SHOTS, Florida’s immunization registry and (b) FAP will include my personal immunization information in Florida SHOTS and my personal immunization information will be shared with the Centers for Disease Control (CDC) or other federal agencies.
- I further authorize Fifth Avenue Pediatrics to submit a claim to my insurance provider for the above requested items and services. I assign and request payment of authorized benefits be made on my behalf to Fifth Avenue Pediatrics with respect to the above requested items and services.
